## THE TOBYHANNA TOWNSHIP BOARD OF SUPERVISORS SPECIAL MEETING MAY 17, 2017

A special meeting of the Tobyhanna Township Board of Supervisors was held on May 17 2017 at the Tobyhanna Township Government Center Building, 105 Government Center Way, Pocono Pines, Pennsylvania 18350.

Present were Supervisors Anne Lamberton, John Holahan, Heidi A. Pickard, Brendon Carroll and John E. Kerrick, Township Manager John Jablowski Jr, Zoning Officer Maureen Minnick, Township Engineer Bob McHale.

- 1. Chair Anne Lamberton called the meeting to order at 8:00 a.m. It was determined that a quorum was present.
- 2. Pledge of Allegiance was recited.
- 3. Announcements:

Executive Session was held on May 11, 2017 from 9:35 a.m. to 10:15 a.m. to discuss a possible litigation issue.

Next Executive Session is scheduled for June 12, 2017 at 5:00 p.m.

- 4. New Business
  - A. Signs

Heidi Pickard begins discussion on signs in the cart way versus the right of way. Ms. Pickard suggests that it needs to be defined better including that there are also PennDot requirements that may need to be considered. Mr. Jablowski suggests applicants call PennDot division to get clear requirements.

Mike Christian adds that another section was added per Jonathan Reiss's request that says that any sign in the township's right of way that needs to be removed for road widening projects will be done at the sign owner's expense. Discussion continues on the cart way and right of way sign removal costs and how PennDot handles such issues.

John Holahan begins discussion on digital signs being approved in the commercial district. Suggests that he would like to see a map showing where the digital signs could possibly be to understand better the impact of digital signs in the scenic bi-way. Discussion ensues about the possibility of a village overlay.

Brendon Carroll suggests the purpose of the ordinance is so that there are rules and guidelines for sign owners to follow – until then any one is free to do what they want.

Maureen Minnick brings up concern of charging the same tax rates to commercial property owners who would not be permitted to have a digital sign as those who would be allowed the digital sign use. Suggests that the digital signs either need to be allowed or not allowed across the board for everyone.

John Jablowski discusses the option of developing a neighborhood commercial zone. John Holahan discusses the option of developing a commercial resort zone.

John Kerrick suggests having a meeting to hear from the public for their opinion. Anne Lamberton and Brendon Carroll agree. Bob McHale suggests having Adams come in to display the size and brightness of an actual digital sign would look like so people have an idea of exactly what to expect. John Jablowski agrees to contact Adams.

Heidi Pickard made motion to approve RKR Hess desktop study in the amount of \$8,500. John Holahan seconded. Vote: All in favor; motion carries.
