What the list does:

- The list is a listing of parcels in your community which we were able to identify as containing land in the Special Flood Hazard Area (SFHA) as per the preliminary Flood Insurance Rate Map (FIRM).
- The list acts as a tool for municipalities to assist in outreach to landowners whose properties are either wholly or partly located in the Special Flood Hazard Area, also identified as Zones A and AE, as per the preliminary Flood Insurance Rate Map.
- Why conduct outreach? Landowners who hold federally-backed mortgages on structures located in the Special Flood Hazard Area are required to purchase flood insurance. You may have residents or businesses that are not currently located within a floodplain but will be located in the floodplain once the new Flood Insurance Rate Map becomes effective. While the new Flood Insurance Rate Map is still in the preliminary stage, each community should reach out to those who may be affected. If those affected by the change purchase flood insurance prior to the issuance of the final effective Flood Insurance Rate Map, they will be grandfathered to receive a reduced premium for the life of their insurance policy so long as the policy does not lapse.

What the list does not do:

- Is not intended for making flood zone determinations for either flood insurance or floodplain development purposes. In order to determine if a property or structure is located within a Special Flood Hazard Area on the preliminary Flood Insurance Rate Map, it is imperative that the preliminary Flood Insurance Rate Map be looked at by property owners, especially in areas where the floodplain boundary intersects small parcels, to verify their inclusion on the list.
- It is not a list of those parcels which will have a change in flood zones. An accurate GIS data layer of the current Flood Insurance Rate Map does not exist to offer that comparison.
- It is not a list of those parcels located in the floodplain on the current Flood Insurance Rate Map. In order to determine whether or not a property is located in the SFHA on the current Flood Insurance Rate Map, please reference the current Flood Insurance Rate Map at your municipal building or at the FEMA Map Service Center: <http://msc.fema.gov>.
- In order for a citizen to make a comparison between the new (preliminary) and current Flood Insurance Rate Map, they should either visit the municipal building to view both paper maps, or they should visit the FEMA Map Service Center: <http://msc.fema.gov> for the current maps and the FEMA RAMPP website: <http://www.rampp-team.com/public.htm> for the new (preliminary) maps.
