- 7. Manager Report:
 - a. Pocono Mountain Regional EMS Donation Request: Robert Bartal states Jeanine Hofbauer from PMREMS requests a donation in lieu of the Round Up Fundraiser. He reviews the recent donations made. John Kerrick states PMREMS may need additional help because of the pandemic. David Carbone asks if there are any other donation requests expected.
