A Special Meeting of the Tobyhanna Township Board of Supervisors ("Board") was held on January 26, 2023, at the Tobyhanna Township Government Center located at 105 Government Center Way, Pocono Pines, PA 18350.

John Kerrick, David Carbone, Brendon Carroll, Rachel Schickling virtually, and Joseph Colyer, are present. Also present is Solicitor Harry Coleman virtually, Robert Bartal, Manager, and Autumn Canfield, Assistant Manager.

- 1. John Kerrick calls the meeting to order at 9:09AM, a quorum is present.
- 2. The Pledge of Allegiance is recited.
- 3. Announcements: John Kerrick announces an executive session was held on February 13, 2023 from 8:45AM to 9:05AM for Personnel and legal.

4. Discussion Items:

a. Discuss Appointments: Brendon Carroll motions to appoint Tia Fritz to the Zoning Hearing Board to fill a 4-year vacated term, David Carbone seconds. Vote: all in favor; motion carries. - b. Gratz Washenik asks about a resolution for an intermunicipal agreement for a taxing district with Coolbaugh as he also serves as their tax collector. Brendon Carroll motions to enter in to an intermunicipal agreement conditioned on review by the Solicitor, David Carbone seconds. Vote: all in favor; motion carries.
