# TOBYHANNA TOWNSHIP BOARD OF SUPERVISORS REGULAR BUSINESS MEETING August 21, 2023

The July Regular Business Meeting of the Tobyhanna Township Board of Supervisors was held on August 21, 2023, at the Tobyhanna Township Government Center Building located at 105 Government Center Way, Pocono Pines, PA 18350.

Present are Supervisors John Kerrick, David Carbone, Brendon Carroll, Rachel Schickling and Joseph Colyer. Also present are Solicitor, Harry Coleman, Esquire, Manager Robert Bartal and Assistant Manager Crystal Butler.

- 1. John Kerrick calls the meeting to order at 6:00PM; a quorum is present.
- 2. The Pledge of Allegiance is recited.
- 3. Announcements: John Kerrick states that an executive session was held on July 17, 2023, from 5:30PM to 5:58PM for legal and personnel. Mr. Kerrick states that an executive session was held on July 17, 2023, from 7:25PM to 7:45PM for legal. Robert Bartal states that an executive session was held on August 21, 2023, from 5:30PM to 6:00PM personnel.
- 4. Consider Minutes: Rachel Schickling motions to approve the minutes of the June 19, 2023, Regular Business Meeting, July 5, 2023, Joint Board of Supervisors/Economic Development Authority; and July 17, 2023, Regular Business Meeting as presented, Joseph Colyer seconds. Vote: all in favor; motion carries.
- 5. Solicitor Report: Mr. Coleman states that a litigation report was sent to the Board of Supervisors on August 5, 2023.

Mr. Coleman advises that he received an Advice of Counsel Opinion from the Pennsylvania State Ethics Commission stating that it would not be a conflict of interest for Mr. Colyer and Mr. Carbone to vote on issues regarding the fire department.

Mr. Coleman states that he received a Deed of Dedication from the developer dedicating to the Township St. Luke's Way and the Hudock Road cul-de-sac. Mr. Coleman is asking for a motion to authorize the Vice-Chairman to sign the Deed of Dedication for St. Luke's Way and the Hudock Road cul-de-sac from Tobyhanna Site LLC. Mr. Bartal asked if the Township Engineer should review this before it is signed, and Mr. Coleman said yes. John Kerrick entertains the motion with the review of the Township Engineer. Brendon Carroll makes the motion, David Carbone seconds. Vote: 4-0, John Kerrick abstains; motion carries.

Mr. Coleman requests the Board for a motion to advertise the Resolution adopting the Deed of Dedication of St. Luke's Way and the Hudock Road cul-de-sac along with a motion to advertise the vacation of the unused portion of Hudock Road. John Kerrick entertains a motion for permission to advertise. Rachel Schickling and Jospeh Colyer motion to grant permission to advertise. David Carbone seconds. Vote: 4-0, John Kerrick abstains; motion carries.

Mr. Coleman states that the Township is looking into refinancing a vehicle. Mr. Coleman states that the Township must follow the Local Government Unit Debt in terms of

refinancing. Mr. Coleman has made a call to counsel for DCED concerning this issue and will report to the Board at the next meeting.

{Agenda Item taken out of order: Mr. Coleman states that since this is in litigation, he discussed this matter with the Board in an executive session. This matter is tabled.}

## 6. Manager's Report:

- a. Penn Strategies Report: Robert Bartal states that Penn Strategies has reached out to set up a meeting within the next two weeks to plan the strategy for next year.
- b. Zoning and Septic Reports: Robert Bartal reviews the July 2022 and July 2023 zoning and septic reports.
- c. Legacy Donation for PMREMS Regional Roundup August 31, 2023: Robert Bartal announces that the PMREMS Regional Roundup will take place on August 31, 2023, from 5:30PM to 9:00PM at Skytop Lodge.

- a. PMRPC: Brendon Carroll states they are under 72 hours for the month, and they are still over about 410 hours for the year. Mr. Carroll states that through the summer, crime is down.
- b. PMREMS: Joseph Colyer states they received one of the new ambulances. Mr. Colyer states that coverage in the building is solid, very few shifts are uncovered now.

{Agenda Item taken out of order: Austin Schraeder (?) from PMREMS states that last month was a busy month. There were 153 responses and 62% of those calls required patient transfer to the hospital. Mr. Schraeder stated that they have hired 8 new employees.}

- f. PM COG: Crystal Butler states that they did have their July meeting and they are still working with other Townships regarding Act 167.

repairs in Camelot and Lake Naomi. David Carbone states that he received calls stating that they did a great job. Mr. Rafferty states that they restriped the township building, Locust Ridge, and the fire department.
